#### REPRESENTATIVE CASES

Lead counsel for the plaintiff electronics/entertainment company in what at the time was the largest set of MDL patent cases in the United States, pending in the Northern District of Georgia and relating to scrolling cable guide technology, helped obtain numerous settlements totaling over \$200 million (based on public information).

Lead counsel defending a specialty minerals company in a patent case involving precipitated calcium carbonate, pending in the Southern District of New York, obtained an order granting our motion for waiver of privilege under the crime-fraud exception (one of only 2 such rulings in a patent case at the time), sending the case to trial under an innovative high/low agreement focused on a key technical issue as to which the Court ruled in the client's favor.

Lead counsel in trial of generic pharmaceutical case pending in the District of Delaware, involving a proton pump inhibitor product with a market value of over \$200 million, obtained a judgment of non-infringement in favor of the generic pharmaceutical client.

Lead counsel for generic pharmaceutical company in patent case involving omeprazole, a blockbuster product (i.e., market value of over 1 billion), tried month long case in the Southern District of New York.

Lead counsel for plaintiff smart card patent holder versus major retailor in case pending in the Northern District of Georgia, obtained favorable mediation settlement.

Part of a partner team, represented a Master Distributor of electronic products, including HVAC products, in asserting trademark infringement claims against competitor in the District Court for Oklahoma, obtained a very favorably settlement during mediation based on expert damages report Mr. North crafted (according to mediator comments).

Special master appointed by the Northern District of Georgia in two patent cases, one involving the permeability of a hamburger wrap/covering and the other involving a ladder for getting in and out of the water on motorboats, issued tentative claim construction ruling and a report and recommendation, which was adopted by the district court, after which the cases settled.
